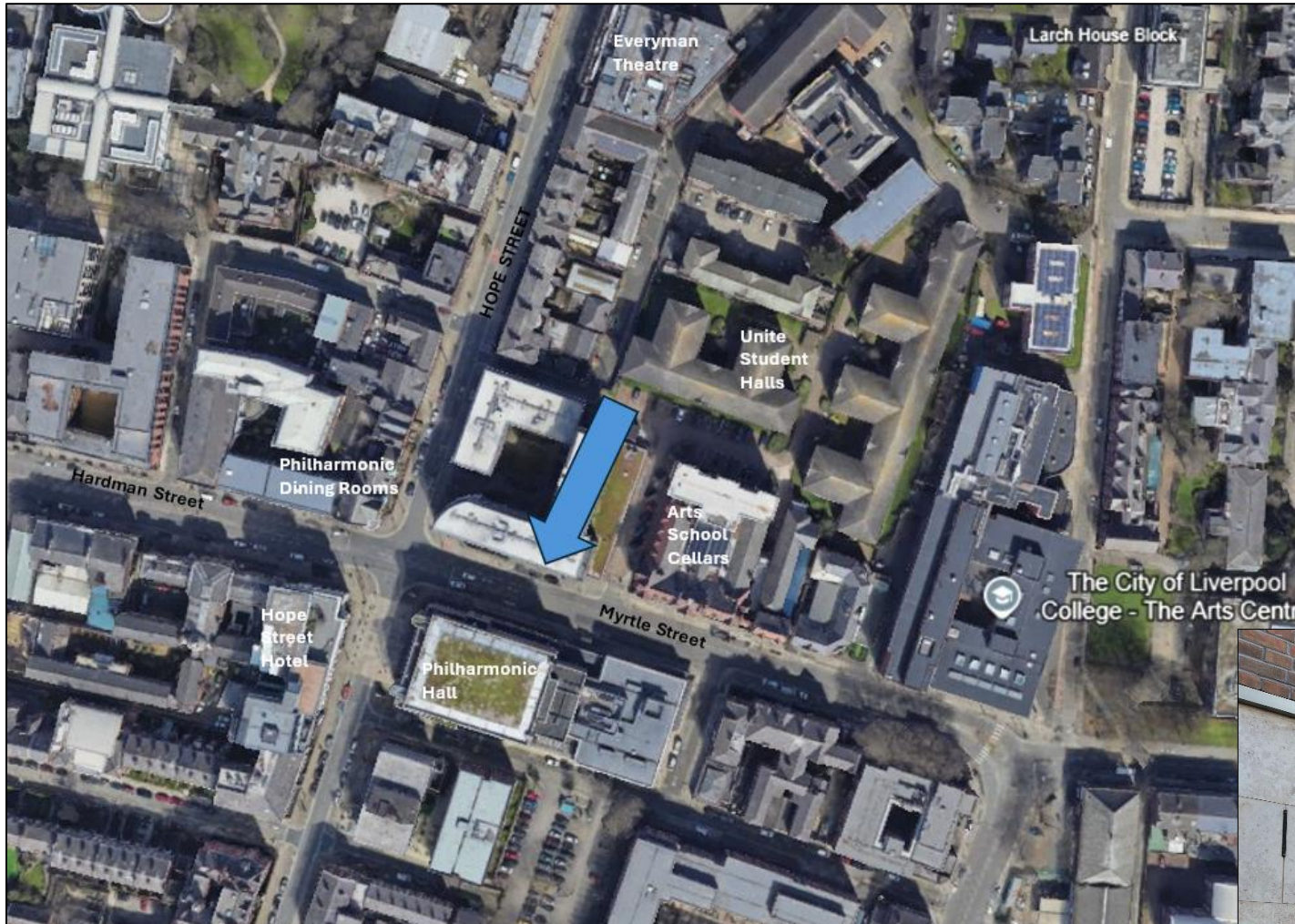

Location

The property enjoys a prime position in the heart of Liverpool's University District and Knowledge Quarter, surrounded by a mix of residential, educational and cultural institutions.

Myrtle Street links directly into Hardman Street and leading through to Bold Street and Renshaw Street, placing Liverpool city centre within easy walking distance.

There is excellent road access via the A5038 which connects to Liverpool's inner ring road and the M62 motorway (approx. 3.5 miles away). Lime Street Station, the city's main rail hub is just 1 mile away with frequent local bus services enhancing the connectivity.

Situated opposite the iconic Philharmonic Hall and the renowned Philharmonic Dining Rooms, the property is surrounded by celebrated venues and amenities including The Everyman Theatre, Hope Street Hotel, The Art School Cellars and popular dining spots such as Queen of Hope Street Pub, Chatime, Pepe's Chicken, Vetch, Fredericks, The Pen Factory and the Liverpool Arts Bar.
